

## **AEGEAN FREE ZONE DEVELOPMENT AND OPERATING CO. SPACE CAMP TURKEY**

### **INFORMATION AS PART OF THE LAW ON PROTECTION AND PROCESSING OF PERSONAL DATA**

#### **1. IDENTITY OF DATA CONTROLLER**

Personal Data shall be processed by The Aegean Free Zone Development and Operating Co. ("Space Camp Turkey"), as Data Controller, within the framework of the Law no 6698 on Protection of Personal Data ("Law").

#### **2. PURPOSE OF PROCESSING PERSONAL DATA**

Collected Personal Data may be processed by Space Camp Turkey in conformity with the basic principles set forth by the Law and within the framework of the conditions and purposes of processing personal data as stipulated in Articles 5 and 6 of the Law.

- Planning and execution of the company's human resources policies and processes
- Execution of the relevant departmental activities to ensure access to the company's services by the relevant people and carrying out the necessary processes.
- Planning and performing the necessary activities to suggest and promote the company's products and services by personalizing them in accordance with the tastes, usage habits and needs of people
- Carrying out the necessary projects by the departments to ensure realization of the company's commercial activities and executing the relevant business processes.
- Planning and execution of the company's commercial and/or business strategies
- Ensuring the legal, technical and commercial safety of the company and relevant people involved in business relations with the company

### **3. PARTIES TO WHOM PERSONAL DATA ARE TRANSFERRED AND PURPOSES OF TRANSFER**

Space Camp Turkey may transfer the personal data to relevant government institutions as well as private organizations that are authorized by law in conformity with the basic principles set forth by the Law and within the framework of the conditions and purposes of processing personal data as stipulated in Articles 8 and 9 of the Law to serve the below objectives::

- Planning and execution of the company's human resources policies and processes
- Execution of the relevant departmental activities to ensure access to the company's services by the relevant people and carrying out the necessary processes
- Planning and performing the necessary activities to suggest and promote the company's products and services by personalizing them in accordance with the tastes, usage habits and needs of people
- Carrying out the necessary projects by the departments to ensure realization of the company's commercial activities and executing the relevant business processes
- Planning and execution of the company's commercial and/or business strategies
- Ensuring the legal, technical and commercial safety of the company and relevant people involved in business relations with the company

### **4. METHOD OF COLLECTING PERSONAL DATA AND CAUSE OF ACTION**

Personal data are collected using a variety of means to ensure execution of the Company's operations on the basis of the legislations and the causes of action of compliance with company policy. Collected personal data may be processed and transferred within the framework of the conditions and purposes of processing personal data as stipulated in Articles 5 and 6 of the Law under the objectives listed within this Statement of Information.

## 5. RIGHTS OF PERSONAL DATA OWNERS AS PER ARTICLE 11 OF THE LAW

Personal Data Owners shall be entitled to the below listed rights as per Article 11 of the Law:

With this application form, you hold the right to;

- a) Learn whether or not your personal data have been processed
- b) Request information as to processing if your data have been processed
- c) Learn the purpose of processing of the personal data and whether data are used in accordance with their purpose,
- d) Know the third parties to whom the data have been transferred
- e) Request rectification in case personal data are processed incompletely or inaccurately
- f) Request deletion or destruction of personal data in case the reasons necessitating their processing cease to exist
- g) Request notification of the rectifications, deletions or destructions on the data to third parties to whom personal data have been transferred
- h) Object to occurrence of any result that is to your detriment by means of analysis of personal data exclusively through automated systems,
- i) Request compensation for the damages in case the person incurs damages due to unlawful processing of personal data
